GUIDELINES FOR PROOF OF FUNDING DOCUMENTATION: Submit your **passport** with the correct documents for your sponsorship type below.

1. Personal/Family sponsor
 - a. Proof of income for each sponsor. This can be the most recent end-of-year tax documents (tax returns) or current proof of payment by employer (pay stub)
 - b. Bank statements for each sponsor showing at least 6 months of balances and activity. A letter from the bank or a single balance statement IS NOT sufficient
 - c. Affidavit containing the name of the source and the amount available for each year of study in USD. Please complete the Agreement for Financial Support form.
2. Business funds:
 - a. If you are receiving funds from a business account, you must provide the business registration, which states the name(s) of the business owner(s).
 - b. Profit/Loss statement, usually included in the business tax documents, that shows that the business is operating at a yearly profit of at least your total cost of attendance. Bank account statements for a business will not be accepted.
 - c. Official sponsorship letter from the company owner(s).
3. Scholarships and Financial Aid:
 - a. If you are receiving an external scholarship, please provide a letter from that source stating the amount awarded to you and the duration of support. Please specify currency where applicable.
4. Government or Employer:
 - a. If you are receiving funding from a government or employer, please provide a letter from that source stating the amount awarded to you and the duration of support.
5. Loans:
 - a. Official letter from credit institution indicating approval of loan and amount approved.
 - b. If the loan is awarded to a person other than the student, please provide an affidavit form.
